RECREATIONAL ACCESS INFORMATION

Updated April 17, 2019

Our website, www.wyrecreation.com, is now updated with information about the 2019-20 recreational permit period. Lease information will be updated at a later date. 2018-19 recreational permits are current through July 23, 2019.

ACCESS INFORMATION

Alsea Area:

- The South Toledo/1000 Line is open to motorized access, along with the 1100, 1014 to Table Mtn, 1040, 1060, 1080 to 1040 junction, and 3800 roads.
- At all other gates in the Alsea area, non-motorized access is allowed behind gates that are NOT posted as Recreational Leased property or No Trespassing.

Mid-Coast Area:

- **The majority of Black Rock is a permit area.** *Permits for 2019-20 go on sale Tuesday, May 7, 2019, 7:00 pm.* Mill Creek is open for non-motorized access in areas outside our permit/lease program. The Valsetz ML is open for thru traffic only and will close at the start of 2020 fire season.
- **North Toledo (North of Hwy 20):** The Gorge Mainline Road is open for motorized access during weekends/holidays and non-motorized access during weekdays. Follow all posted signs regarding the Travel Management Area and active harvest areas.
- **Trask:** Baker Creek, White and Vonn Road gates are open for motorized access. All other areas outside our permit/lease program are open for non-motorized access.

Clackamas Area:

- **Molalla and Estacada/Hood River** are permit areas. *Permits for 2019-20 go on sale Wednesday, May 8, 2019, 7:00 pm.*

Snow Peak Area:

- **The majority of Snow Peak is a permit area.** *Permits for 2019-20 go on sale Tuesday, May 7, 2019, 7:00 pm.* Trask Road (aka US Ply), Thomas Creek and Green Mtn. are open for non-motorized access in areas outside our permit/lease program.

Springfield:

- *Permits for 2019-20 go on sale Thursday, May 23, 7:00 pm.* Lane and Linn county properties, outside of our recreational permit/lease program, are currently open to non-motorized access.

When on our timberlands...

- Access is only permitted 1½ hours before sunrise and closes 1½ hours after sunset.
- Stay clear of all active work areas, obey all signs and do not block gates when you park.
- ATV, ORVs, motorcycles or motor-assisted bicycles are NOT allowed.

- When motor vehicles are allowed, they must stay on improved rock roads only.
- Target shooting, trash dumping, camping, fires, and removal of firewood or any special forest products is NOT allowed.
- Firearms are only allowed for licensed hunters during State-regulated hunting seasons. Licensed hunters must obey all State hunting regulations.

SCATTERED LEASE TRACTS

We have scattered leased tracts located throughout the Willamette Valley Region. These tracts are posted “**No Trespassing –Private Recreation Lease**” and are closed to all entry unless you have a lease.
