ERM Certification and Verification Services, Inc ("ERM CVS") was engaged by Weyerhaeuser Company ("Weyerhaeuser") to provide limited assurance in relation to the selected 2020, 2021, and 2022 information set out below and presented on pages 3 and 4 in the Weyerhaeuser Carbon Record ("the Report"), and in the 'Greenhouse Gas' data table on the Weyerhaeuser Data and GRI Index website ("the Website").

Our conclusion

Based on our activities, as described below, nothing has come to our attention to indicate that the 2020, 2021, and 2022 data and information for the disclosures listed under 'Scope' above are not fairly presented, in all material respects, in accordance with the reporting criteria.

Our assurance activities

Considering the level of assurance and our assessment of the risk of material misstatement of the selected information as presented in the Report, a multi-disciplinary team of sustainability and assurance specialists performed a range of procedures that included, but was not restricted to, the following:

- Assessing the appropriateness of the reporting criteria for the Report and the Website.
- Interviews with management representatives responsible for managing the selected disclosures.
- Interviews with relevant staff to understand and evaluate the relevant management systems and processes (including internal review and control processes) used for collecting and reporting the selected disclosures.
- A review at corporate level of a sample of qualitative and quantitative evidence supporting the reported information.
- An analytical review of the year-end data submitted by all locations included in the consolidated 2020, 2021, and 2022 group data for the selected disclosures which included testing the completeness and mathematical accuracy of conversions and calculations, and consolidation in line with the stated reporting boundary.
- Visits to four Weyerhaeuser facilities/production sites in the US and Canada to review source data and local reporting systems and controls.
- · Confirming conversion and emission factors and assumptions used.
- Reviewing the presentation of information relevant to the scope of our work in the Report and the Website to ensure consistency with our findings.

The limitations of our engagement

The reliability of the assured information is subject to inherent uncertainties, given the available methods for determining, calculating or estimating the underlying information. It is important to understand our assurance conclusions in this context. Our independent assurance statement provides no assurance on the maintenance and integrity of the Website, including controls used to achieve this, and in particular, whether any changes may have occurred to the information since it was first published.
