RECREATIONAL ACCESS INFORMATION

Updated December 16, 2016

This portion of the Recreation Hotline covers the Springfield Area which includes:

- Weyerhaeuser ownership in Lane County primarily east of Interstate 5 and N. of Highway 58
- Wendling Travel Management area in Lane and Linn Counties
- Alsea/Triangle Lake area west of I-5
- Former Plum Creek lands near Toledo South of Hwy 20

ACCESS INFORMATION

Permits are not required for the Wendling Travel Management area, Alsea/Triangle Lake area, Former Plum Creek lands south of highway 20, and select areas in Lane and Linn Counties.

• Lane and Linn County (North Calapooia): Lane and Linn County property outside of our recreational lease and permit program, is currently open to walk in access — weekends and after 4pm on weekdays. It is your responsibility to ensure you are not in a lease or permit area.

Hunters with late-season controlled hunt tags for the 219A (S. Central McKenzie Elk) and 219B (NW McKenzie Elk) will be given vehicle access behind locked gates. This special access privilege is for Saturdays and Sundays only. Keys are issued at our Springfield Main Office located at 785 N. 42nd St., Mondays through Fridays, from 8 AM-12PM & 1-5PM on 12/19-12/22 and 12/27-12/30. Hunters will have access to the following gates: Mohawk, Mill Creek, Gate Creek, Calapooia ML, Calapooia 100, Calapooia 3000. Please check the hotline on Fridays to see if these gates have changed.

In order to obtain a key for controlled hunts, you will need to present a valid driver's license, your hunting license & tag, a description of your vehicle, including license plate number, proof of insurance for your vehicle, and a check for a \$100 key deposit payable to Weyerhaeuser.

- Wendling Travel Management Area (TMA): is open through the end of November. As of December 1st 2016 this area is walk in only on weekends 1.5 hours before sunrise to 1.5 hours after sunset and after 4pm on weekdays until 1.5 hours after sunset. Do not drive into the TMA area or you may end up with a trespass ticket and/or locked behind a gate.
- **Booth Kelly/Fall Creek:** are permit areas. For additional information or to purchase a permit please go to www.wyrecreation.com.
- Alsea/Triangle Lake: property outside of our recreational lease program, is currently open to walk in access weekends and after 4pm on weekdays. It is your responsibility to ensure you are not in a lease area.

• Toledo South of Highway 20: Gates are open for motorized access. Follow all posted signs and leave gates closed when you find them shut.

SCATTERED LEASE TRACTS

We have scattered leased tracts located throughout the Springfield area. These tracts are posted "**No Trespassing –Private Recreation Lease**" and are closed to all entry unless you have a lease. For more information on leases please visit www.wyrecreation.com.

- Stay clear of all active work areas, obey all signs and don't block gates when you park.
- No ATV, ORVs, motorcycles or motor-assisted bicycles
- When vehicles are allowed, they must stay on improved rock roads only.
- Access is only permitted one and a half hours before sunrise and closed one and a half hours after sunset.
- No target shooting, trash dumping, camping, fires or fireworks.

This message will be updated after 12:00 noon on Fridays if any changes are made to our access policy. This information, and all rules and regulations for the Springfield Forest Area, can also be found by calling 541/741-5403, prompt 4.
